

## Adiles – End User License Agreement – A01

### Important - Read Carefully

This End User License Agreement constitutes a legal agreement between the End User and Adiles AS (herein Adiles)

This agreement is for the use of all software, either produced by Adiles or delivered to End user from an Adiles supplier or a partner.

Adiles which includes any software, media, and accompanying on-line or printed documentation and direct or indirect access to the program table structures for reporting (excluding the actual user-entered data contents) which collectively are the Intellectual Property of Adiles or the companies represented by Adiles.

By clicking on the accept button during the install procedure, installing, copying or otherwise using the Software or signing a copy of this agreement, you agree to accept and be bound by the terms of this License Agreement. If you do not agree to the terms of this License Agreement, do not install or use the Software and return all unused copies in your possession to Adiles AS.

### 1. GRANT OF LICENSE

- Install and use the Software on the number and types of computers as per the License.

Type; and

- Copy the Software for back-up and archival purposes provided any copy must contain all of the original Software's proprietary notices.

In the event of termination of the agreement between End User and Adiles, this License Agreement will terminate and Adiles will assume a relationship with you or arrange for another party to assume the relationship with you. You may choose to continue using the Software, provided that you enter into the respective vendors partner channel or the relevant parties' standard terms and conditions at that point in time.

### 2. LICENSE RESTRICTIONS

You may not:

- Permit other individuals to use the Software except under the terms of this License Agreement.
- Modify, translate, reverse engineer, decompile, disassemble (except to the extent that this restriction is expressly prohibited by law) or create derivative works based on the Software.
- Copy the Software (except for back-up or archival purposes).
- Resell, rent, lease, transfer, or otherwise transfer rights to the Software; or
- Remove any proprietary notices or labels on or in the Software.

### 3. LICENSE TYPES

The Software is licensed through a number of different license types, to which the additional:

1. Connection to the database requires the purchase of a Client Access License. The maximum number of computers, workstations or users that may directly or indirectly access or otherwise utilize the Database at any given point in time may not exceed the number of Client Access Licenses that you have purchased. Use of software or hardware that reduces the number of users directly accessing or utilizing the Server-installed Software (sometimes called "multiplexing" or "pooling" software or hardware) does not reduce the number of Client Access Licenses required.
2. Client Access License. On payment of the License, the license code will be issued for a Client Access License. This Client Access License allows you to install the Software on the hard disk of a single computer for access to the Database installed on the Server. The maximum number of computers, workstations or users that may directly or indirectly access or otherwise utilize Server-installed Database or the Software at any given point in time may not exceed the total number of Client Access Licenses that you have purchased.
3. Evaluation Client Access License. If you have obtained permission from Adiles to evaluate the Software, you may install the Software on a temporary basis for evaluation purposes only. The evaluation period is limited to the permitted days from the date the Software is installed. Upon completion of the Evaluation Period your license to use the Software expires. During the Evaluation Period, the software is provided on an "as is" basis and you assume the entire risk as to the quality and performance of the software. If you have obtained permission from Adiles to evaluate a multi user version of the Software. The evaluation version of the Software is not licensed for an initial implementation toward Go Live.
4. Upgrade License. If you have purchased the Software as an upgrade, the Software constitutes a single product together with the product that you upgraded and may not be used to increase the total number of licensed copies of the Software.

### 4. MAINTENANCE

Maintenance of the Software will be exclusively supplied by Adiles to you in accordance with the maintenance schedule attached to this License Agreement. You acknowledge that any failure to use the Maintenance provided by Adiles or other vendors represented may prevent Adiles or vendors represented from being unable to identify and assist in the correction of potential problems which, in turn, could result in an unsatisfactory software performance. Failure to use the Maintenance will also result in you Not receiving any of the Software updates or upgrades issued by vendors represented from time to time.

## 5. THIRD PARTY SOFTWARE PRODUCTS

This license does not grant you any rights in relation to any third-party software products required in conjunction with the Software, for example third party database products. You are responsible for obtaining the necessary licenses for such third-party software products as you may require. You acknowledge that the licensing scheme for third party software products may not correspond with the licensing scheme for the Software. This license does not include licenses to any 3rd Party database server software that is required to correctly operate the Software.

Adiles will provide you with a license code representing the Client Access License to allow full use of the Software once Adiles receives payment of the License Fee.

## 6. TITLE

Title, ownership, rights, and intellectual property rights in and to the Software shall remain in Adiles or to the vendors represented. The Software is protected by the copyright laws of the international copyright treaties. Title, ownership rights and intellectual property rights in and to the content accessed through the Software shall be retained by the applicable content owner and may be protected by applicable copyright or other law. This license gives you no rights to such content.

## 7. NO WARRANTIES

YOU UNDERSTAND AND AGREE THAT THE SOFTWARE IS PROVIDED "AS IS" AND ADILES, ITS AFFILIATES, SUPPLIERS AND RESELLERS EXPRESSLY DISCLAIM ALL WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION ANY WARRANTY OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE OR NON-INFRINGEMENT. ## 9. INDEMNIFICATION

You agree to indemnify, defend and hold harmless Adiles, its affiliates, officers, directors, employees, consultants, agents, suppliers and resellers from any and all third party claims, liability, damages and/or costs (including, but not limited to, attorney's fees) arising from;

- (i) your use of the Software,
- (ii) your violation of this Agreement,
- (iii) the infringement or violation by you or any other user of your account, of any intellectual property or other right of any person or entity, or
- (iv) if the Software is imported from the United States, import and export duties or other claims arising from such importation.

## 10. TERMINATION

This License Agreement will automatically terminate if and when you fail to comply with any term hereof. No notice shall be required from Adiles to affect the termination specified in the preceding sentence. You may also terminate this License Agreement at any time by notifying Adiles in writing of termination. Upon any termination of this License Agreement, your license shall immediately terminate, and you shall discontinue use of the Software.

Upon any termination of this Agreement, you must cease any further use of the Software and delete/destroy any copies of Software (including all elements thereof such as documentation) within your possession and control.

## 11. ASSIGNMENT

This Agreement is personal to you and may not be assigned by you without Adiles express written consent. This Agreement shall be binding upon any party who uses the software and/or any party to whom you transfer the Software.

You agree that you are responsible for informing all users and transferees of the Software of the binding application of this Agreement, and all provisions contained herein, to such user(s) and transferee(s).

Adiles may assign this Agreement without your approval in the event there is a reorganization, consolidation, merger or acquisition of substantially all of the stock or assets of Adiles.
